## **ABSENTEE BALLOTS**

**June 12, 2019** at the Compliance Building located at 1325 Broadway Plaza Fresno CA from 10:00 a.m. to 1:00 p.m. and 6:00 p.m. to 9:00 p.m. in the Room 119 for Compliance, Accounts Management, MITS and all employees assigned to the Compliance Building.

**June 13, 2019** at the Fresno Service Center located at 5045 E Butler Fresno CA from 10:00 a.m. to 1:00 p.m. and 6:00 p.m. to 9 p.m. in the Westside Cafeteria for Submission Processing, both Processing and Post-Processing, AWSS, MITS, TAS and other employees assigned to the Butler Building as well as all other members from the other buildings who did not get to vote in their buildings.
