THE ELECTION

The Election will be conducted by Ballot Box on **August 23-25, 2022**. Members may vote at any of the election sites. For seasonal employees, if on furlough, it is recommended that they vote at their most recent Post-of-Duty or request an absentee ballot.

ABSENTEE BALLOTS

Members who will not be at their current Post-of-Duty during the Election may make requests for **absentee** ballots to the NTEU Chapter 97 Election Committee at **PO Box 1832 Fresno CA 93717**, or email election2022@nteu-97.org. Ballots must be **received by August 26, 2022, at 11:00 am**.

****Absentee ballots can be requested at any time but you must mail the ballot early enough to be received at PO Box 1832 Fresno CA 93617 by the August 26, 2022, 11:00 am deadline. NOTE: August 26, 2022 at 11:00 am, is the date the ballot must be received by the Election Committee. This is NOT a postmark date. *****

VOTING

Voting will be at the following dates and locations:

August 23, 2022, at Northpointe located at 3211 South Northpointe Dr. Fresno CA from **12:00 p.m. to 5:00 p.m. in the Breakroom**, for all employees assigned to the Northpointe building.

August 24, 2022, at the Compliance Building located at 1325 Broadway Plaza Fresno CA from **10:00 a.m. to 1:00 p.m. and 6:00 p.m. to 9:00 p.m., Room 142** for Compliance, Accounts Management, MITS and all employees assigned to the Compliance Building.

August 25, 2022, at the Tower Building located at 855 M Street Fresno CA from **10:00 a.m. to 1:00 p.m. and 6:00 p.m. to 9:00 p.m., Rooms 602-603**, for Accounts Management, Tax Accounts/Resources Management, and MITS at the Tower.

Please bring your badge or other federal or state issued identification.

Write-in candidates will not be allowed.

TALLY OF BALLOTS

The ballots will then be tallied at **12:00 p.m., August 26, 2022**, at the **Tower in Rooms 602-603**. The candidate receiving a plurality of votes for each particular office shall be declared the winner.
